EXPLANATION: Florida has a law known as the Marketable Record Title Act (MRTA). MRTA provides that restrictive covenants may be extinguished after a period of thirty years. Florida's law also provides that a homeowner's association may vote to extend covenants for a period of an additional thirty years. The vote required by MRTA is 2/3rds of the members of the board of directors at a meeting for which a notice, stating the meeting's time and place and containing the statement of marketable title action described in F.S. 712.061(1)(b) is mailed or hand delivered to members of the homeowners' association not less than 7 days prior to such meeting.






